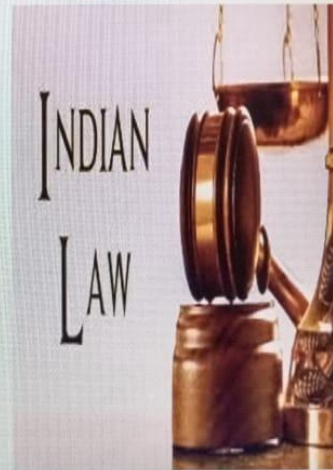

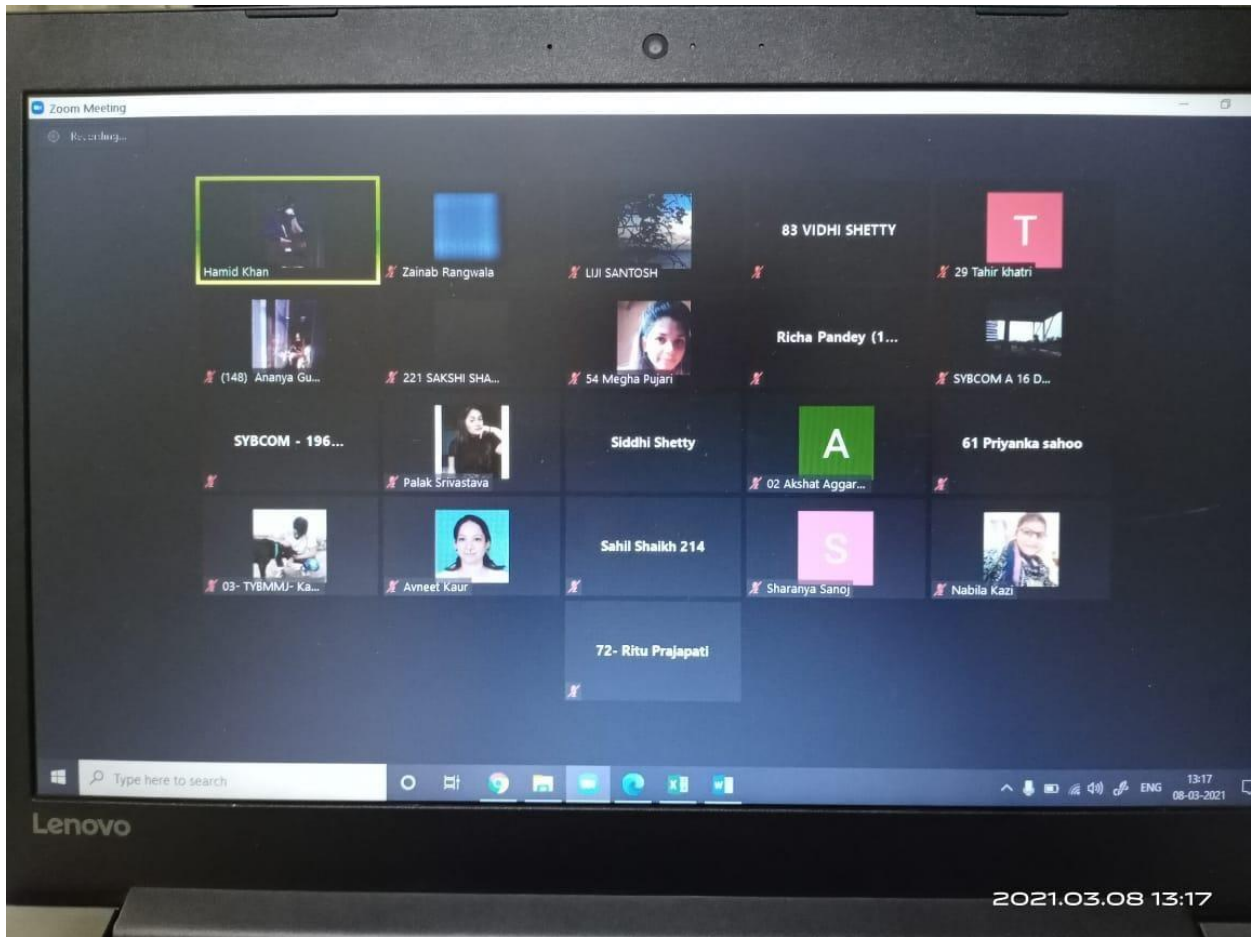

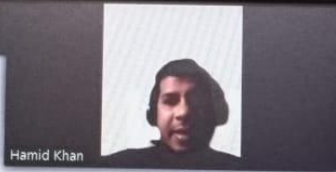

3. Women have the right to get free legal aid
 - All female rape victims have the right to free legal aid, under the Legal Services Authorities Act.
 - It is mandatory for the Station House Officer (SHO) to inform the Legal Services Authority, who arranges for the lawyer.
